NEPCSA Committee Descriptions



Board of Directors

Members of the NEPCSA Board of Directors are responsible for ensuring that the association stays on track in meeting the organization's mission, services, policies and programs.

Board members have a fiduciary responsibility to review and approve the association's budget and financial strategy.

They approve major policies, serve on committees or task forces, take on special assignments and promote the association to others in the private career school industry.



Membership Committee

NEPCSA recognizes that the most effective marketing tool for membership growth is a peer-to-peer recruitment, and a retention program led by volunteer members.

The NEPCSA Membership Committee develops strategic plans and sets recruitment and retention goals each year.



Government Affairs Committees

The NEPCSA Government Affairs Committees are responsible for representing and protecting the private career school's legislative interests.

The NEPCSA Government Affairs Committees monitor the regulatory process, and acts on legislation that can impact the private career school sector.



Education Committee

The NEPCSA Education Committee is responsible for determining the membership's educational needs and implementing programs to meet those specific needs.

The Education Committee also plans the NEPCSA Annual Conference, which features numerous educational workshops and exhibits, as well as networking and constructive interaction with public officials, vendors, faculty, school owners and administrators.
